With a legacy dating back to the mid-nineteenth century, Windels Marx has been an integral part of the formative events of the practice of law in New York, with founding members and officers of the New York State Bar Association and the Association of the Bar of the City of New York, and of American corporate history. Indeed, the Firm represented Thomas Edison in litigation which confirmed his claim to be the inventor of the incandescent electric light in the late 1800s and was responsible for incorporating IBM in the early 1900s. The most recent merger, between Windels, Marx, Davies & Ives and Lane & Mittendorf, LLP, brought together two established firms, thereby creating a practice encompassing a greater depth of experience and an increased ability to handle more sophisticated transactions, as well as a growing client base. Our already strong New Jersey practice was enhanced by the addition of seven partners from the highly regarded, former Princeton law firm, Jamieson Moore Peskin & Spicer.
